The company is obliged to manufacture components according to the DNV Rules whenever the components are design approved by DNV. This obligation is effective without detriment, regardless of contracts closed between manufacturer and customer. If no Approval of Manufacturer (AoM) certificate is necessary for the construction of certain components being examined by DNV, the company is only free of the obligation if they submit notification in writing to DNV before construction begins.

The company shall prepare an inspection plan for each type of component before start of construction and submit it to DNV. The plan shall clearly indicate the duties of construction and quality control. This inspection plan has to be approved by DNV prior to start of production.

Alterations or modifications within the company having substantial influence upon the manufacturing quality (e.g. alterations in construction methods and/or construction facilities) and changes in the qualification of personnel are to be immediately indicated in writing to the DNV surveyor in charge or to DNV Approval Centre.

Should any check reveal any deviations from the AoM certificate a determined period will be arranged for the elimination of these deviations and if necessary, a subsequent examination will be undertaken. Should the subsequent examination establish that the deviations have not been eliminated, DNV is entitled to withdraw the approval.

Should DNV get knowledge about any damages on products the company is responsible for, DNV is entitled to suspend the AoM certificate until the deficiencies are remedied or to withdraw this certificate.
