## Nomination Committee for the Saab Annual General Meeting 2019

In addition, the Chairman of the Board of Directors shall also be a member of the Nomination Committee.

The Nomination Committee represents approximately 54 percent of the total voting rights of Saab AB based on the ownership structure as of August 31, 2018.

The Annual General Meeting of Saab AB will be held on Thursday, 11 April 2019.
